Long-time BlueOx Credit Union Board Member, Robert Harvey, is retiring from our volunteer Board of Directors at the end of his term in April. A BlueOx member since 1960 and volunteer since 1964, Bob earned several of the credit union industry's highest honors from the Credit Union National Association (CUNA), including the Edward A.
